			<ul> <li>Any concerns or injuries must be reported immediately and will be investigated as soon as possible so that arrangements can be put in place to avoid a recurrence;</li> </ul>
			<ul> <li>Test strip must not be used if the sealed packaging is damaged;</li> </ul>

However, if they choose to participate in the LFD testing programme after completing their self-isolation period and they have a positive LFD test they will be required to self-isolate for a further 10 days or possibly longer if still symptomatic.</li> </ul>
